Car import history

- End of 2011- started to import cars
- About 550,000 imported passenger cars and 350 000 trucks/bus in Myanmar
- 98% is used cars and 2% is new cars.
- Most of cars are imported from Japan.
- 70% of cars were registered in Yangon

- 1. Custom duty -30-40%
- 2. Commercial tax- 5%
- 3. Income tax- 15%
- 4. Special good tax- 20-50% (> 1500CC)
- 5. Road Registration tax- 30-100%
